Candidate Profile STP Communicating with the Public

Organisations and candidates that qualify for participation in Shiraka training Communicating with the Public are:

- 1. Organisations that operate in the field of:
 - This course isn't related to certain policy topics. But the course is most relevant for
 organisations who have a key position in communicating with the public. For instance
 because their policy's or the execution of these policy's effect the lives of many
 citizens.
- 2. Organisation with the following responsibilities:
 - Making and/ or implementing policy's on national, regional or local level.
 - · Organisations who are strongly involved with the public
 - · Organisations who want to involve the public
- Civil servants who work on the topics:
 - Organizational communication
 - Corporate communication
 - External communication
 - Media affaires
 - Providing information to the public/ stakeholders
 - Communication about government policy
 - PR and branding
- Civil servants who have experience with:
 - They are communication professionals, or communication is a large part of their job description/ responsibility's.
 - They preferably work in a communication department
 - They are responsible for leading a communication department, making communication policy's or communication projects.
- Candidates who possess the following qualities/skills:
 - Are motivated to acquire knowledge and skills
 - Are motivated to do things in a different way when they get back home
 - 5-10 yrs working experience
 - Language: they speak and write Arabic and/or Englisch and/or French in a way that is sufficient enough to exchange knowledge on the topic of communicating with the public.

Ontional

The training is not suitable for candidates from organisations:

- Who are not communicating with the public
- Who's main focus is journalism (it's not a training for journalists)

Optioneel

The training is not suitable for participants who:

- People who don't have any responsibility's regarding communicating with the public.
- People who don't have any experience or knowledge in the field of communication



Shiraka and the COVID-19 outbreak
Because of the current outbreak of COVID-19 throughout the world, we
offer this training programme at least partly as an online course.
If possible (taking into account worldwide corona measures), a part of the
programme will take place in the Netherlands.

Dates, location and language

The professional development course will take place from January to March
2022. The training weeks in January and February will take place online.

The Netherlands invites civil servants from the MENA region to apply for a professional development course on Communicating with the Public.

Eligible countries are: Algeria, Egypt, Iraq, Iran, Jordan, Lebanon, Libya, Morocco, Mauritania, Oman, Palestinian Territories, Sudan, Tunisia.

The objective of the course is for civil servants working in the field of government communication to share their knowledge and skills enabling them to lead and inspire the modernisation of government communication in their home countries. The course also aims to strengthen participants' ties with the Netherlands and the Dutch government; especially between Dutch civil servants and their counterparts in the target countries.

Goals of the 'Communicating with the Public' professional development course

development course

The Ministry of Foreign Affairs of the Netherlands is organizing the professional development course with the following aims:

To increase the participant's knowledge about government

- communication theory and an understanding of the relationship between government policy and communication and the role of communication with the public in a democratic society.
- To increase the participant's insight in processes and in the playing field between government and citizens and the
- consequences for their respective governments.

 To increase practical skills, knowledge and professional competencies with regard to communication in the playing field between government and citizen.

Additionally, the course provides participants the opportunity to develop a valuable network with other civil servants in the region and in the Netherlands.

Action Plan

The course will also allow the uptake of the learned principles in a practical project. Every participant will work on a Back Home Action Plan (BHAP). The BHAP describes a specific project in communication with the public, such as: writing a plan for the (improvement of) the communication function within the own organization, making a plan for the further professionalization of one or several communications aspects (such as communications advice, press relations, research), or making a communication plan for a specific project in which communication with the public plays an important role. Each participant starts with the BHAP during the first online part of the programme and presents their plan to the group on the final day of the course.

Costs and fees

The Dutch government will take care of all relevant costs for participants from countries on the <u>OECD-DAC list</u>. This includes international travel, board and lodging, visa and insurance, and tuition fees for the course. Participants from countries that are not on the OECD-DAC list will pay for their own international travel costs; flight tickets and visa. Board and lodging, insurance and tuition fees for the course will be covered by the Dutch government. All applicants are responsible for the organisation and costs of travelling to the airport in their own country. Participants from countries on the OECD-DAC list departing from an international airport outside their own country, will have to cover local travel expenses themselves and will be compensated for the international part of their journey.

Participants are responsible for the organisation of their visa application.

In case of no-shows or cancellations within four weeks before the start of the first part of the training, the organisation has the right to claim all costs incurred from the participants' employer.

Eligibility criteria

- Administrative check. Fully documented applications received before the deadline.
- Match of job position and learning goals with the topics of the course and motivation.
- Between 5 and 10 years relevant work experience as civil servant in government communication.
- No (previous) participation in other Shiraka or Matra-South Training Programmes.
- ICT. To follow the online course, the participant must have sufficient computer skills and must have internet access to follow the online meetings.

We encourage female civil servants to apply, as we highly value diversity amongst our participants. There are 25 places available, which will ideally be divided equally between the invited countries. A passive understanding of the English language would be a plus. Please be aware that this won't be used as a selection criteria.

Shiraka training programme

The course will be organized as part of the Shiraka programme, an initiative of the Ministry of Foreign Affairs of the Netherlands. Shiraka is a Dutch bilateral effort dedicated to contributing to political development in the MENA region. Through this Shiraka training programme, the Netherlands Ministry of Foreign Affairs aims to stimulate and support sustainable transition in the MENA region and to strengthen relations between the Netherlands and the target countries.
